DISCLAIMER, ASSUMPTION OF RISK AND WAIVER: I acknowledge that participation in soccer involves travel, play in adverse field conditions, contact with considerable force and risk of severe, permanent physical injury, including bruises, scrapes, strained, sprained or torn muscles, tendons or ligaments, broken bones, dislocation of joints, concussion, brain damage, nerve and spinal cord injury, paralysis and death. I WILLINGLY AND VOLUNTARILY ASSUME ALL SUCH RISKS. I willingly and voluntarily agree to comply with the stated and customary terms and conditions for participation and, if Player or I observe any concern in Player's readiness for participation in the Events, I will remove him/her from participation and bring such concern to the attention of the nearest official immediately. Permission is granted for my child to receive emergency medical treatment if needed. Permission is granted to photograph my child during camp and any sponsored events with the understanding that Newbury Park Soccer Club retains the rights to use these visual images for publicity purposes or in any other manner without compensation to my child.

I HEREBY RELEASE, DISCHARGE AND AGREE TO HOLD HARMLESS, to the fullest extent permitted by law, Newbury Park Soccer Club, its players, employees, volunteers, officials, sponsors and other representatives and any and all owners, lessors, lessees or other persons or entities allowing, permitting or authorizing the use of facilities by Newbury Park Soccer Club and the agents, employees, officers and directors of said persons or entities ("Releases") from any and all claims, demands, costs, expenses and compensation arising out of or in any way related to an injury or other damage that may result to said participant or to members of my family or my household or individuals I invite or for whom I am otherwise responsible while participating in or present at any of the EVENTS, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
